

Lieutenant Governor's Faith in Action Award

The Award to be presented honours exceptional community outreach that is recognized as having provided significant benefit to the wider community. The outreach is given by an individual and is driven by their religious commitment to the faith tradition to which they themselves belong.

For Nominating an individual

- The award is open to any Nova Scotian or individual whose work is in Nova Scotia and which benefits a community in Nova Scotia and improves the quality of life for people within this province
- The nominated work can either be a body of work carried out over time and that continues in the current award year, or a significant achievement that took place within in the current award year.
- The successful nominee must be able to attend AST spring convocation

The nominations submitted should include details about the type of achievement to be recognized, the involvement of the nominated individual and the impact of the achievement on the wider community, and individuals within the community.

Please ensure nominations answer the following questions. (Your nomination should not exceed 300 words.)

- Please provide a clear description of the program or activity and describe the individual's involvement.
- What is your understanding of the nominee's reasons for being involved in this work?
- How long has the nominee been involved with the program or activity?
- Describe the benefits this program provides beyond the nominee's own religious community.
- What, in your view, makes this program or activity unique and successful?

How to Nominate an Individual

1. Complete the award nomination form. Please be clear and concise in your responses to the questions.
2. Fill out the consent form. Be sure to provide the nominee's signature and contact information.
3. You are encouraged to provide a letter of support from a recognized leader within the faith community of the individual nominated. This person must have direct knowledge of the work to be recognized.

The Lieutenant Governor's Faith In Action Award Advisory Committee will review and evaluate all nominations based on adherence to the following principle...

- The commitment to public service is directly shaped and driven by the nominee's faith and beliefs.
